RECOMMENDATION

Recommendation to enter into a contract with Touchstone IQ LLC, DBA Touchstone IQ, 2000 S Colorado Blvd., ANNEX Bldg., STE 460, Denver, CO 80222 in relation to Request for Proposal PS20230253-PUDS-RFP - Provision of a Software as a Service Building Performance Reporting System ("BPRS") and Other Services.

The Chief Procurement Officer recommends that the Bid Committee approve the entry into the following contract, under the authority of the City's Procurement Policy ADMIN-008 (subject to final negotiations).

Recommended Vendor:	Touchstone IQ LLC, DBA Touchstone IQ
Contract Term and Contract Value:	The recommended term of the contract is five (5) years, with the option to extend for two (2) additional two-year terms. The contract price is \$1,093,749.94, plus applicable taxes, over the initial five-year term of the contract.

- c) Financial Planning & Analysis and the applicable business unit have reviewed and concur on the budget and recommendation;
- d) Bid Committee approval authority exists, as outlined in the City's Procurement Policy ADMIN-008 due to the value being in excess of \$750,000;
- e) The Category Manager, Chief Procurement Officer, and General Manager, Planning, Urban Design and Sustainability to be authorized to execute and deliver all legal documents on behalf of the City; and,
- f) The Bid Committee approval is pre-contract award, the final contract information may vary subject to final negotiations and award.
